- Senate Commerce Committee Chair, Jason Schultz, introduced SSB 1224 -- a bill to prevent credit unions from purchasing banks. The CBI Board took a position to SUPPORT this legislation and we are registered FOR the bill.
- There will be a subcommittee on SSB 1224 at 12 noon on Monday, 3/1.
- SSB 1151, a bill to create a central filing system for security instruments in farm products, was passed in the Senate State Government Committee (2/24). It will receive a new bill number and be placed on the Senate debate calendar.
