• The Division of Banking's overhaul legislation, SF 586, passed the Iowa Senate this week on a 45-0 vote. As it includes an appropriation, it is exempt from any funnel deadlines. That said, the Iowa House does NOT have a companion bill on the calendar and this bill will need to clear a committee in the House before it can be considered by the full body.
